

## Presidential statement for Wounded Knee Medalist

The Rosebud Sioux Tribe's President released a statement responding to the recent decision made by Secretary of Defense Pete Hegseth. President Kathleen Wooden Knife of the Rosebud Sioux Tribe has issued a strong response to Secretary of Defense Pete Hegseth's recent decision regarding the 1890 Wounded Knee Medal of Honor recipients. Recently, Secretary Hegseth publicized that the 20 soldiers who obtained the Medal of Honor for their actions at Wounded Knee would continue to keep their awards.

President Kathleen Wooden Knife responded, *"To this day, our families carry that pain. To continue to decorate those responsible with our nation's highest military honor is not only historically inaccurate, but it also dishonors every Veteran who has truly earned the Medal through valor and sacrifice."*

*"The Rosebud Sioux Tribe is deeply disappointed in the administration's decision to allow Medals of Honor to remain with the soldiers who carried out the Wounded Knee Massacre.*

*What happened at Wounded Knee in 1890 was not a battle; it was the slaughter of more than 250 peaceful Lakota men, women, and children. To this day, our families carry that pain. To continue to decorate those responsible with our nation's highest military honor is not only historically inaccurate, but it also dishonors every Veteran who has truly earned the Medal through valor and sacrifice.*

*Even Major General Nelson Miles, who oversaw soldiers involved in the massacre, described it as "the most abominable military blunder and a horrible massacre of women and children" rather than a legitimate engagement. Nearly a century later, Senator Daniel Inouye, a Medal of Honor recipient, sponsored Joint Resolution 153 (1990), which expressed "deep regret on behalf of the United States to the descendants of the victims and survivors" of the massacre.*

*Miles's condemnation and the U.S. Congress's later apologies do not indicate an honorable engagement but a cowardly act.*

*The Rosebud Sioux Tribe has long called for these Medals to be rescinded, along with many Tribal Nations and allies who know the difference between courage in war and the taking of innocent lives. By refusing to act, the administration perpetuates a grave injustice and diminishes the meaning of the Medal itself.*

*The Rosebud Sioux Tribe will continue to press for justice. Healing cannot come when the government continues to honor those who took part in one of the darkest chapters in American history."*

## Presidential Staff Participate in Parades






### War Bonnet Finds It Way Home

October 20th, 2025, Rosebud, SD. An eagle feather War Bonnet was repatriated to the Rosebud Sioux Tribe by US Fish and Wildlife agents. The bonnet was confiscated in February of 2020 by US Customs Agents and sat five years in federal confinement until a Federal Judge remanded it to the custody of the Rosebud Sioux Tribe. During the administration of former RST President, Rodney Bordeaux, a formal correspondence was sent to the US Fish and Wildlife Service, advocating for the War Bonnet's return. Its eventual repatriation was commemorated with a sentimental ceremony, attended by representatives from the THPO office, the RST President's Office, the Treasurer's Office, and other employees. This occasion serves as a compelling affirmation of the enduring vitality of traditional legal frameworks and the paramount importance of cultural preservation for the Rosebud Sioux Tribe.


### REDCO Presents Dividend Check to the Rosebud Sioux Tribe


# Flu SEASON

#### 1. Why get vaccinated?

Influenza vaccine can prevent influenza (flu).

Flu is a contagious disease that spreads around the United States every year, usually between October and May. Anyone can get the flu, but it is more dangerous for some people. Infants and young children, people 65 years and older, pregnant women, and people with certain health conditions or a weakened immune system are at greatest risk of flu complications.

Pneumonia, bronchitis, sinus infections, and ear infections are examples of flu-related complications. If you have a medical condition, such as heart disease, cancer, or diabetes, flu can make it worse.

Flu can cause fever and chills, sore throat, muscle aches, fatigue, cough, headache, and runny or stuffy nose. Some people may have vomiting and diarrhea, though this is more common in children than adults.

In an average year, **thousands of people in the United States die from flu**, and many more are hospitalized. Flu vaccine prevents millions of illnesses and flu-related visits to the doctor each year.

#### 2. Influenza vaccines

CDC recommends everyone 6 months and older get vaccinated every flu season. **Children 6 months through 8 years of age** may need 2 doses during a single flu season. **Everyone else** needs only 1 dose each flu season.

It takes about 2 weeks for protection to develop after vaccination.

There are many flu viruses, and they are always changing. Each year a new flu vaccine is made to protect against the influenza viruses believed to be likely to cause disease in the upcoming flu season.

#### 4. Risks of a vaccine reaction

- Soreness, redness, and swelling where the shot is given, fever, muscle aches, and headache can happen after influenza vaccination.
- There may be a very small increased risk of Guillain-Barré Syndrome (GBS) after inactivated influenza vaccine (the flu shot).

Young children who get the flu shot along with pneumococcal vaccine (PCV13) and/or DTaP vaccine at the same time might be slightly more likely to have a seizure caused by fever. Tell your health care provider if a child who is getting flu vaccine has ever had a seizure.

People sometimes faint after medical procedures, including vaccination. Tell your provider if you feel dizzy or have vision changes or ringing in the ears.

As with any medicine, there is a very remote chance of a vaccine causing a severe allergic reaction, other serious injury, or death.

#### 5. What if there is a serious problem?

An allergic reaction could occur after the vaccinated person leaves the clinic. If you see signs of a severe allergic reaction (hives, swelling of the face and throat, difficulty breathing, a fast heartbeat, dizziness, or weakness), call 9-1-1 and get the person to the nearest hospital.

For other signs that concern you, call your health care provider.

Adverse reactions should be reported to the Vaccine Adverse Event Reporting System (VAERS). Your health care provider will usually file this report, or you can do it yourself. Visit the VAERS website at [www.vaers.hhs.gov](http://www.vaers.hhs.gov) or call 1-800-822-7967. *VAERS is only for reporting reactions, and VAERS staff members do not give medical advice.*

Even when the vaccine doesn't exactly match these viruses, it may still provide some protection.

Influenza vaccine **does not cause flu**.

Influenza vaccine may be given at the same time as other vaccines.

#### 3. Talk with your health care provider

Tell your vaccination provider if the person getting the vaccine:

- Has had an **allergic reaction after a previous dose of influenza vaccine**, or has any **severe, life-threatening allergies**
- Has ever had **Guillain-Barré Syndrome** (also called "GBS")

In some cases, your health care provider may decide to postpone influenza vaccination until a future visit.

Influenza vaccine can be administered at any time during pregnancy. Women who are or will be pregnant during influenza season should receive inactivated influenza vaccine.

People with minor illnesses, such as a cold, may be vaccinated. People who are moderately or severely ill should usually wait until they recover before getting influenza vaccine.

Your health care provider can give you more information.



#### 6. The National Vaccine Injury Compensation Program

The National Vaccine Injury Compensation Program (VICP) is a federal program that was created to compensate people who may have been injured by certain vaccines. Claims regarding alleged injury or death due to vaccination have a time limit for filing, which may be as short as two years. Once there was a man, a fine hunter and good provider, who was very much in love with his wife. They had two beautiful children, with a third on the way.

When his wife was about to give birth, she was in labor for a long time. The baby wouldn't come out, and it hurt so much that the woman cried. The husband fetched an old woman who knew about such things, and she tried birthing medicine and all her other powers. But nothing helped; the child wouldn't come out, and the young wife died.

The husband was crazy with grief. He had loved her so much, and now he didn't know what to do. He ate almost nothing. He cut his little finger off to show how much he missed her. He held all kinds of ceremonies for her. Sometime after she had died, the man was walking near his tipi one night when he saw a ghost. It was something like a white fog, a mist shaped like a woman. It was his wife, calling him. She said:

"I couldn't stand seeing you grieve so much. I took pity on you. It's not at all bad where I am, and I can arrange for you and the children to join me. Then we can walk the Milky Way together and never be separated again."

The man said: "Come into the tipi. Let's talk this over."

So the white shape went inside with him. They sat down. The man said: "I'm not quite ready to die yet. And the children are too young to die. Instead of our going with you to that spirit place, can't you arrange it so that you come to life again and stay with us?"

The ghost didn't know, and said she would ask and return in four days with an answer.

Four days later she came back, standing outside the tipi in the moonlight like a white mist. She called her husband and told him:

"Well, all right; it's arranged for me to come to life again. Make a curtain of buffalo robes that I can hide behind, and don't look at me or try to touch me for four days. If you do, I'll remain dead, so be careful, Husband."

The man followed every instruction. He hung the curtain and didn't look or let the children look behind it. He did everything right. And after four days his wife came out from behind the curtain, young and pretty as before. The couple and their children lived again as if she had never died. They were happy together.

When years had passed, however, the man fell in love with another woman. He told his wife: "I shall marry a second woman, and she will share the work with you. You'll have someone to talk to when I'm away hunting. Things will be more pleasant."

But things were not so pleasant. The first wife tried to get along with the second one, but the new woman was proud and jealous. And as often happens, the man paid more attention to his new wife, the younger and prettier one. The new woman did not like having the old one around, either, and she told her:

"You're nothing but a ghost; you're not even real. Why do you hang around? Why don't you go back up to the Milky Way where you belong? Go away, ghost!"

The first wife said nothing, but the next morning she was gone, and her husband and children also were gone with her. They had vanished without a trace. This time the ghost wife had taken them to the spirit land rather than stay with them down on earth. When the new wife realized what had happened, she was sorry for what she had said, but that didn't bring them back.

Re: Impacts of Government Shutdown—SNAP, WIC and LIHEAP

Dear Senator Thune, Senator Rounds, and Representative Johnson:

*Anpetu Waste'*—Good Day. Thank you for your leadership in difficult times. I write on behalf of the Rosebud Sioux Tribe to ask you to work to re-open the Government and fund our Public Law No. 93-638 Indian Self-Determination Programs. The Rosebud Sioux Tribe of the Rosebud Sioux Reservation is composed of 38,000 tribal members located on 1,300,000 acres in South Central South Dakota and, as you know, we have urgent Tribal Government needs.

***PLEASE SAVE SNAP AND WIC***

As America's largest food safety network, Supplemental Nutrition Assistance Program helps 42 Million Americans. For decades, our Todd County on the Rosebud Sioux Reservation has been the poorest or the second poorest county in America based upon per capita income, so 60 to 70% of our Rosebud tribal members rely on SNAP due to our extreme poverty and unemployment. As the Government Shutdown drags on, our November benefits are threatened and our People need to eat.

The Women Infant Children Program is very important for our young mothers, infants and children. WIC provides the nutrition our young mothers, infants and children need to survive and thrive. The program helps mothers, infants and children up to five years old with healthy foods, nutrition education, breast feeding support, and community support. WIC is essential for young families.

Please end the Government Shutdown to save SNAP and WIC.

## ***PLEASE SAVE LIHEAP***

In the winter, the cold at Rosebud Sioux reaches minus 25 degrees below zero. Despite our best efforts at economic development, our poverty rate remains high, unemployment is high, and our median income is low, much lower than the rest of America. Our people suffer poor housing, poor health status, and every year, some of our Lakota People run out of propane for heat and use space heaters, kerosene, or wood stoves to burn whatever they can. With our poor housing stock, we typically see plastic on windows and people have poor insulation in their homes, so people die from carbon monoxide poisoning and freezing.

The **Low Income Home Energy Assistance Program (LIHEAP)** is designed to help households with low incomes—especially those facing the highest energy burdens—manage the cost of home energy. Its main goals are to:

- **Assist with heating and cooling bills**, especially during extreme weather.
- **Provide crisis energy assistance**, such as help during utility shutoffs or fuel shortages.
- **Support weatherization efforts**, like improving insulation or repairing heating systems, to reduce long-term energy costs.

LIHEAP is federally funded and administered by states, tribes, and territories, which distribute the aid to eligible households. The Rosebud Sioux Tribe provides LIHEAP benefits to Native Americans in Todd, Gregory, Mellette, and Tripp Counties in South Dakota.

Medical statistics say that Cold Weather deaths increased by double from 1999 to 2022 from .44 per 100,000 to .92 per 100,000, as reported by the Journal of American Medical Association. In that timeframe, more than 40,000 people died nationwide from the cold weather, and American Indians and Alaska Natives are most at risk nationwide from death due to cold because of deficient housing and poor health conditions. *LIHEAP is essential to keep our Lakota People at Rosebud Sioux alive in the long, cold months of winter from October into April each year.*

***During the shutdown, the Rosebud Sioux Tribe has had to shift \$120,000 from other priorities this month to address LIHEAP and keep assistance going to our tribal members. The weather is starting to turn towards winter, and we are concerned for our people's health and survival. Annually, LIHEAP provides \$1.2 to \$1.4 Million to our Rosebud tribal members for energy assistance.***

*Please help the Rosebud Sioux Tribe make our Reservation a livable home, in accord with the 1868 Treaty, and help save us from deaths, freezing and injury. Please fully fund LIHEAP and end the Government Shut Down. Wopila Tanka—Thank you!*


